

What is AVID and why is it important in Clovis Unified?

AVID stands for Advancement Via Individual Determination. AVID strategies are engaging and increase rigor naturally in the classroom as they use the elements of WICOR (Writing, Inquiry, Collaboration, Organization, and Reading). AVID strategies are research-based and support all students in their journey of discovery and learning. AVID builds community, connectedness, and culture. Student and teacher connections build relationships which cultivate a learning environment suitable for all.



AVID For Elementary Schools

Preparing teachers and students for success

AVID Elementary engages young learners and provides critical skills to propel learner confidence and the ability to critically think, read, and write. Teachers use AVID strategies to provide students with WICOR scaffolds which build rigor through engagement, as well as provide confidence in academic discourse in all content areas.

CUSD AVID Program

Advancement Via Individual Determination (AVID) is a college and career readiness system of strategies designed to prepare all students for success in elementary, middle, and high school, for college, career, and beyond. Clovis Unified Schools have embraced the implementation process of schoolwide AVID strategies in the elementary and secondary levels, leading to increased student engagement and academic achievement for all students in the Clovis Unified School District.

The greatest growth in 2023-24 was in AVID Elementary, as eight more elementary schools were onboarded, now totaling twenty-two sites. All ten comprehensive intermediate and secondary sites are longstanding with implementing AVID strategies; currently, there are a total of 30 schools participating in AVID for the 2023-24 school year.

AVID's mission is to close the opportunity gap through rigorous, first-time best instruction, holding high expectations, and providing strategies to scaffold learning for curriculum. AVID uses a comprehensive approach in supporting students with strategies and procedures to increase college and career readiness from transitional kindergarten to twelfth grade. When staff and teachers employ AVID strategies, students become interconnected in lessons and build background knowledge from one content-area lesson to another, naturally building rigor in learning. Critical thinking, reading, and writing are key components in WICOR (Writing, Inquiry, Collaboration, Organization, and Reading). AVID strategies include WICOR and are interwoven into classroom lessons and become more rigorous as students advance from one grade level to another.

AVID provides teachers with academic strategies of engagement and the ability to build relational capacity in the classroom and all over campus, creating strong connections with staff, students, and the community. AVID Elementary is a testament to CUSD's commitment to equipping the youngest learners with the skills and mindset for future successes. AVID develops an academic culture of learner's growth mindset, which bridges from elementary to secondary, with a goal of growth mindset throughout life.

Through AVID site team meetings, and the growing number of AVID-trained teachers and sites, who are implementing AVID strategies, Clovis has stayed committed to growing academic achievement for all learners. This year, almost 400 educators have been trained in AVID and more than 58 professional learning opportunities have been provided for Clovis educators and administrators. Through AVID training, teachers have received comprehensive professional development in AVID methodologies, emphasizing the use of writing, inquiry, collaboration, organization, and reading (WICOR) strategies which are used across all content areas. AVID's WICOR integration increases rigor, enhances student engagement, promotes critical thinking, and problem-solving skills in all grade-level classrooms. Students are regularly engaged in focused notetaking, collaborative group work, and organizational academic skills through the implementation of AVID routines in classrooms.

With AVID, student agency and leadership are nurtured. AVID fosters leadership skills among students by providing opportunities for them to take leadership roles and practice academic discourse in a guided, collaborative manner. These experiences provide students with the grounding needed to lead collaborative study groups, Socratic questioning, peer mentorship, and voluntary participation in community service. CUSD AVID students led community service projects including the December Canned Food Drive, serving at the Poverello House, volunteering in support of Veteran's Day, volunteering at CUSD elementary school carnivals, in food pantries and site clothing closets. Students participated in AVID organized blood drives, elementary reading and college buddy programs, and site college and career celebrations and fairs. Participation in community service creates a well-roundedness, creating servant-minded students who consider the needs of others.

The Clovis Way entices many to move into the Clovis Unified School District. Clovis schools challenge students to excel in everything they do, parallel to AVID's mission. AVID supports a culture of rigor, high standards, and closing opportunity gaps. AVID-trained educators are intentional in building relational capacity and using strategies to support all learners. Consistent high standards of rigor using routines and procedures ensure equitable opportunities for all in our district. All five CUSD areas are showcased in this report and demonstrate the power of implementing AVID strategies and building a rigorous culture. Through AVID methodology, resources, and ongoing professional learning, student learning is directly impacted. AVID supports all students' growth in mind, body, and spirit and an ongoing commitment to raising academic achievement.



RESOLUTION TO DECLARE CALIFONIA ADULT EDUCATION WEEK April 7-13, 2024

WHEREAS, the first recorded adult education class in California was held in the basement of St. Mary's Cathedral in San Francisco in 1856. The class was authorized by the San Francisco Board of Education to teach English to Irish, Italian, and Chinese immigrants. John Swett, who was the first volunteer teacher for the class, later became a State Superintendent of Public Instruction; and

WHEREAS, adult schools have been utilized on numerous occasions to assist the state as it dealt with significant social, political, and economic issues through job training programs during World War II, immigration reform of the 1980s, and most recently, the Great Recession; and

WHEREAS, adult education in California overcame its biggest challenge as a result of the severe economic crisis facing both the state and the nation in 2008-09. Funding that was previously reserved to adult education was redistributed to other levels of education in the state, resulting in many adult schools decreasing in size with some closing; and

WHEREAS, over 66% of adult learners enrolled in adult schools across California in 2022-23 were between the ages of 25-54, making them very likely to have children in our public school system. The impact of adult education is felt across generations, particularly for early childhood learners who have been characterized as a priority of the Governor and Legislature; and

WHEREAS, Clovis Adult Education successfully serves Clovis Unified School District and the surrounding communities through its collaboration with its community college partners and community-based organizations through the Adult Education system. Clovis Adult Education served 9,145 students in the 2022-23 school year; and

WHEREAS, Clovis Adult Education provides significant and varied classes and programs to Clovis Unified School District and the surrounding communities, including classes in healthcare training, computer technologies training, job preparation classes, high school diploma and equivalency programs, English as a Second Language (ESL) classes, citizenship classes, and more; and

WHEREAS, Clovis Adult Education served students in the high school diploma and GED programs in the 2022-23 school year. The programs help minimize the high school dropout rate. Two hundred eighteen students earned their high school diploma, and 13 students earned their GED in the 2022-23 school year; and

WHEREAS, Clovis Adult Education served 764 students in the ESL Program in the 2022-23 school year, and parents enrolled in ESL classes learn how to assist their children with school work and dedicate several hours a year tutoring their own children; and

WHEREAS, Clovis Adult Education provides a safe environment for its students free from discrimination or bullying regardless of race, ethnicity, religion, sexual orientation or socio-economic status; and

WHEREAS, amid the COVID-19 pandemic Clovis Unified School District continued to provide critical programming and services to our adult education students and their families via literacy and basic skills to help ensure our K-12 students were successful as they navigated the challenge of distance learning to finish the school year; and

WHEREAS, amid the COVID-19 pandemic and continuing today, Clovis Adult Education provides important short-term training programs, including critical healthcare positions, to address the short- and long-term impacts of COVID-19 and to respond to Governor Newsom's charge to address the needs of our communities; and

WHEREAS, the California Adult Education Program celebrates its tenth anniversary this year, having been established in law in 2014; and

WHEREAS, the State of California proclaims April 7-13, 2024, as Adult Education Week.

THEREFORE, BE IT RESOLVED that the Governing Board of the Clovis Unified School District declares April 7-13, 2024, as Adult Education Week and recognizes the important role of adult education in addressing the needs of our communities in the short- and long-term and to increase access to programs and services for the most in-need and not-yet-reached members of our great State.

Title: District School Attendance Boundaries

RECOMMENDATION:

Adopt new District school attendance boundaries as presented in Scenario Silver, effective at the start of the 2025-26 school year.

DISCUSSION:

In January 2024, the District began a community input process to gather feedback on possible adjustments to school attendance boundaries. The study, which started with a months-long process, was conducted at the request of the Governing Board in order to maximize the use of existing schools before building new schools, strive to balance enrollment at schools across the District with future growth patterns considered, and develop a new student attendance area for the Terry P. Bradley Educational Center.

The study looked at the under-capacity and over-capacity schools, anticipated growth areas across the District's 198-square-mile boundary, and enrollment patterns over time to determine the best distribution of attendance boundaries.

On January 26, 2024, two possible scenarios (Scenarios 1 and A) were released, and became the basis for initial meetings with the community in all five high school areas of Clovis Unified. Following a series of well-attended community meetings across the District, and thorough analysis of feedback collected at these meetings and online, District administration then released a revised scenario (Scenario Silver).

Scenario Silver addressed several areas of the District in which information gathered during community meetings indicated a compelling need for revision. Following the release of Scenario Silver, meetings were held at individual school sites to further discuss the reasons for changes recommended in Scenario Silver, as well as discuss areas where no changes were made. District staff also met with individual parents to discuss the boundary study.

(Gettysburg)

- Students entering grades 8–9 in Aug. 2025 can remain at Clark/Clovis High School.
- So long as enrollment of at least one sibling at Clark or Clovis High School remains concurrent with younger siblings, then younger siblings can also receive a sibling transfer at the time they enroll in 7th grade.



Whole School Move -Creation of Terry P. Bradley Educational Center (TBEC)

(Boris, Fancher Creek, Hirayama, Temperance–Kutner, Young)

- Families of students entering grades 7-9 in Aug. 2025 who have siblings in grades 10, 11 or 12 at Clovis East High School may choose to access a sibling transfer to keep their concurrently enrolled students all at Reyburn Intermediate and/or Clovis East High School.
- So long as enrollment of at least one sibling at the REC remains concurrent with younger siblings, then younger siblings can also receive a sibling transfer at the time they enroll in 7th grade.

RECOMMENDATION:

Approve the contract with Teachstone to provide a full day of Classroom Assessment Scoring System (CLASS) training for all preschool staff on December 5, 2024.

DISCUSSION:

Beginning in the 2024-25 school year, all California State Preschool Programs (CSPP) will be required by the California Department of Education (CDE) to use the CLASS tool. CLASS describes and supports observations, measurement, and improvement of key features of classroom interactions. CLASS strives to provide emotionally safe and supportive interactions that assess children's behavior, engagement, and cognitive and language development. CLASS measures classroom interactions, defined as the moment-to-moment, back-and-forth exchanges that build and sustain relationships and support child development and learning. Implementation of CLASS will require high-quality staff development.

The District would like to enter into an agreement with Teachstone to provide one full-day "Introduction to Interactions for Educators" training to approximately 150 preschool staff. Trainings are limited to 30 participants per session. Each session incurs a cost of \$7,200 for a total cost of \$36,000.

DISCUSSION:

The Expanded Learning Club (ELC) program in Clovis Unified is funded through the Expanded Learning Opportunities Program (ELO-P) fund to provide free access to before- and after-school learning opportunities for unduplicated students in Transitional Kindergarten through grade 6 at all elementary schools.

The program plan will provide the following opportunities for students and staff:

- An ELC Leadership Team to ensure program implementation meets the Expanded Learning quality standards
- Before- and after-school enrichment activities and learning opportunities at all 35 elementary sites during the school year
- A minimum of 30 days of full-day program during the intersession
- Transitional Kindergarten and Kindergarten students will have access to a nine-hour program
- Ongoing staff trainings
- Maintain and/or add facilities to meet the needs of increasing enrollment

Implementation began in 2022-23 with the original apportionment of \$7,000,000. The ongoing funding will be utilized to grow ELC programs by serving more students each year, and hiring, training, providing ongoing professional development for ELC staff, and enhancing the program facilities.

1- Safe and Supportive Environment

Clovis Unified School District utilizes the Expanded Learning Opportunities Program fund to establish the *Expanded Learning Club* (ELC) program which provides quality academic support and enrichment opportunities outside of the school day for students at all 35 elementary schools in the district. Title I schools and any Community Eligibility Provision (CEP) schools with an Unduplicated Pupil Percentage over 50 percent are granted a sitewide fee waiver that allows all students enrolled access to ELC at no cost.

The Expanded Learning Club's goal is for students to feel success and empowerment while gaining skills and strategies that will help them during the regular school day and prepare them academically and socially for ensuing years. Where feasible, staff are trained in the District's behavior intervention program and social emotional learning curriculum (e.g., Second Step). School-aligned health and safety procedures and policies are in place. Collaborative meetings are scheduled with site administration to further develop a safe and supportive environment. The collaboration between ELC staff, site administrators, and teachers help to identify participant strengths, interests, and learning styles.

Each site is provided with first aid kits and safety clipboards that contain emergency protocols and procedures as well as emergency contacts and a current student roster. The staff are required to wear their CUSD badge, whistles, uniform shirt, walkie-talkie, first aid fanny pack, and carry an emergency clipboard during program hours. Safety drills are conducted on a quarterly basis. The site lead must be CPR/First Aid certified as part of their ongoing training. Additional safety measures include a thorough registration process, attendance tracking system, and release procedures that are aligned with the District's release policies.

To ensure all students benefit from different opportunities that are offered during program hours, a student-to-staff ratio of no more than 17 to 1 in grade 1-6 and a ratio of 10 to 1 for Transitional Kindergarten (TK) and Kindergarten (K) is implemented.

The Child Development Department has invested in multiple well maintained and clean portables at each school site dedicated to ELC programs. Through the strong partnership with site administrators, the staff has been granted access to regular classrooms during the after-school portion of the program.

The program supervisors conduct monthly portable inspections. Findings from portable inspections are used to make decisions about maintenance and repairs of portables. Program growth, due to increased student needs, may require the addition of new portables when fiscally possible, at sites that can accommodate a new building.

2- Active and Engaged Learning

Describe how the program will provide opportunities for students to experience active and engaged learning that either supports or supplements, but does not duplicate, the instructional day.

Hands-on lessons and activities are designed based on student interests. Students are regularly involved in projects and activities that increase understanding and use of creativity, critical thinking, and information and communication technology. A specific focus is placed on Science, Technology, Engineering, and Math (STEM) topics, as well as art (both performing and visual) and Social-emotional learning (SEL) skills. Many collaborative partnerships are established with community vendors through annual contracts to support the enrichment component of our program. Students have access to regular instructional day online resources such as iReady Math and Reading and Accelerated Reading (AR) through their student portal, Clever.com.

3- Skill Building

Describe how the program will provide opportunities for students to experience skill building.

Academic support for students is a priority reflected in the daily schedule. The academic support is aligned and designed to complement the regular school day and focus on meeting proficiency in the California State Content Standards. Students may have up to one hour to complete their homework. The staff collaborates with classroom teachers on student homework completion. On-site credentialed teachers are recruited and contracted to provide targeted academic intervention for students in the after-school programs. Lessons provided are aligned to the California State Content Standards and may have assessments as part of the student progress monitoring process. Students are offered reading and writing opportunities. Literacy activities are at least 15-30 minutes per day for students. Students are given opportunities to practice literacy skills using additional resources such as Accelerated Reader (AR), iReady, and READ 180.

4- Youth Voice and Leadership

Describe how the program will provide opportunities for students to engage in youth voice and leadership.

Students have opportunities to share their viewpoints, concerns, or interests in many ways that help the staff create and establish program expectations and practices. Staff may provide informal and/or formal surveys to students to gauge their interests in what they would like to experience in ELC. Programs have student leaders serve as facilitators for enrichment activities such as clubs, service-based learning projects, and talent shows.

5- Healthy Choices and Behaviors

Describe how the program will provide opportunities for students to engage in healthy choices and behaviors. Describe how students will be served nutritious meals and/or snacks during the ELO-P hours of programing.

Through the partnership with the district's Campus Catering Department, nutritious snacks and meals are offered to all participating students. The staff collaborates with the school to ensure that their healthy practices and program activities are aligned with the school wellness plan. Just like a regular school day, physical education and fitness activities are implemented daily. Teachers are contracted by stipends to provide age-appropriate competitive athletic opportunities for students in grades 4-6. These athletic opportunities are available by sport on a quarterly basis.

6- Diversity, Access, and Equity

Describe how the program is designed to address cultural and linguistic diversity and provide opportunities for all students to experience diversity, access, and equity. Describe how the ELO-P will provide access and opportunity for students with disabilities.

All students enrolled in elementary school are eligible to participate in ELC. Information such as program schedules, fees, locations, and the parent handbook are updated regularly and available on the Clovis Unified School District website under the Child Development Department tab. All elementary schools have a direct link to the Child Development website on their home page. Information posted on the website is accessible in various languages.

During the month of March, program supervisors host parent information meetings at each elementary school to share information about ELC and how to complete an application for their student(s). Informational flyers are translated in Spanish and Hmong and sent home to parents in each school community. Based on the needs of the parents, interpreters are made available at the parent information meetings. The application for ELC is accessible to all parents through their Parent Connect portal starting in April. Students identified as unduplicated pupils are given priority acceptance into programs until facility and/or staffing capacity is reached. Waitlists are created and the remaining students will be added to the program as more staff are hired.

Program supervisors are intentional in hiring staff to reflect the students being served. Staff are trained and encouraged to create positive partnerships with students and families. The various cultures and backgrounds of students are celebrated through activities and lessons that promote positive culture and acceptance.

The partnership between the parents, site administration, and program supervisors help in identifying and providing extra support for any student with academic and/or behavioral challenges including students with an Individualized Educational Plan (IEP). The Behavior Consultation Team (BCT), comprised of a psychologist and two Paraprofessionals, is another resource to support staff and students. The BCT is called upon to assess challenging situations, and to coach and model strategies to support students who display significant struggles. When appropriate, an intervention strategy may include hiring more staff to support specific student needs.

7- Quality Staff

Describe how the program will provide opportunities for students to engage with quality staff.

The ELC leadership team works diligently to recruit, hire, and retain quality staff. Candidates must meet the minimum requirements of the District and go through a thorough interview process prior to obtaining a position in ELC. New staff members hired during the year will attend mandatory training before reporting to their site assignments. All staff are evaluated twice during their probationary period and must meet the job performance standards to obtain permanent status. Credentialed teaching staff and paraprofessional personnel involved in the program at the site level meet the Elementary and Secondary Education Act qualifications for their position. In addition to the required district online training courses, multiple training opportunities are available to staff throughout the school year. Staff serving as Instructor Lead 2, Instructor Lead 1 or TK/K instructors have additional targeted training throughout the year.

8- Clear Vision, Mission, and Purpose

Vision

Clovis Unified School District's Expanded Learning Club strives to be the benchmark for excellence in Expanded Learning programs for students in elementary school.

Mission

The mission of Expanded Learning Club is to provide a safe and supportive expanded learning environment that fosters educational and enrichment opportunities for all students.

Purpose

ELC offers academic support, health and wellness, and enrichment components. The academic support component consists of homework assistance and targeted academic intervention in the focus area chosen by the school site. The health and wellness component consists of physical fitness and education along with a healthy snack. The enrichment component consists of STEM, clubs, community events, service-learning projects, community partners, and much more.

The needs of the community, students, parents, and school are identified through various sources such as annual surveys, parent advisory committee, and student surveys. Once the needs are identified by the site administrators and site supervisor, the focus of the program is established along with the target groups.

Program Goals

- 1. Provide a safe, healthy environment, both physically and emotionally.
- 2. Provide fun and engaging activities for all students.
- 3. Support student academic achievement through standards-based academic and enrichment activities that are aligned with the regular school day.
- 4. Promote parent and community involvement.

Engaged or Will Engage Educational Partners

The program has engaged and will continue to engage its educational partners in the creation of the program's mission, vision, goals, and expected outcomes based on the needs of the specific community. This process will occur through various meetings on a monthly, quarterly, and/or annual basis at the regional, district, and school site level. Annual surveys are sent out to all educational partners to provide input and feedback for the improvement of their site-specific program and the District programs.

Other means of engaging educational partners include sharing information at various Parent Advisory Committee (PAC) meetings at the site and district level; English Learner Advisory Committee (ELAC), School Attendance Review Team (SART), Intercultural Diversity Advisory Council (IDAC), District Migrant Education Parent Advisory Committee (DMEPAC), District English Learner Advisory Committee (DELAC), District Advisory Committee (DAC), and Local Control Accountability Plan (LCAP).

9- Collaborative Partnerships

Evaluation outcomes are used to prioritize future work around program design, professional development, and program practices. Results from the assessment are the driving force behind the Continuous Quality Improvement (CQI) Action Plan. CQI Action Plans are created in the Fall and implemented throughout the Spring.

11- Program Management

Describe the plan for program management.

The ELC leadership team works collaboratively with the site and district administration to assess and utilize funding for their program to support the vision, mission, and goals. The program supervisors ensure each site meets the requirements for providing academic support, enrichment as well as health and wellness activities.

The program plan is updated annually using information from a variety of sources. ELC sites administer student, parent, teacher, and site staff surveys annually. These surveys afford the ELC leadership team an opportunity to evaluate, review and reflect on their program from an internal point of view and collaborate with all educational partners to improve program quality. Other indicators used for evaluation include attendance rates, expenditures, staff development opportunities, parent participation, student achievement, and recommendations for continued improvement. Based on a comprehensive analysis of data and information, the ELC leadership team will identify effective practices and list areas needing improvement.

The ELC leadership team is committed to promoting excellence and high expectations for all students and work to ensure meaningful involvement in decision-making by students, teachers, parents, and community members. The evaluations are shared with, the CUSD Governing Board, District administrators, and staff.

Fiscal Accounting and Reporting

An effective management and fiscal organizational structure is in place to implement policies, procedures, and practices to ensure the successful operation of ELC programs based on program goals, vision, and design. The ELC leadership team is comprised of a Director, Assistant Director, multiple program supervisors and business support team working together to ensure programs adhere to local, state, and federal guidelines.

Reporting requirements and a financial analyst ensures that fiscal, accounting, and record keeping requirements are maintained. The financial analyst and ELC Coordinator work together to ensure all reports are completed by the due dates and ensure the District complies in all areas of spending. The fund will be fiscally monitored through the District's financial system (Munis) and is able to create the financial reports necessary to meet the reporting requirements.

General Questions

Existing After School Education and Safety (ASES) and 21st Community Learning Centers (21st CCLC) Elementary and Middle School grantees.

ASES, 21st CCLC Elementary/Middle School, and the ELO-P should be considered a single, comprehensive program. Under the guidance of the Child Development Director, The ELC Leadership team is comprised of a Director, Assistant Director, multiple program supervisors and business support team to support the school sites. The ELC Leadership team ensures the implementation of one comprehensive and universal expanded learning program using designated ELO-P funds.

Currently, two school sites have both ASES and 21st CCLC programs that serve students only during the after-school portion of the day. The ELO-P funding will expand the existing services to include learning opportunities by adding more capacity to the after-school program and offer services to Transitional Kindergarten/Kindergarten students.

Transitional Kindergarten and Kindergarten

Programs serving transitional kindergarten or kindergarten pupils shall maintain a pupil-to-staff member ratio of no more than 10 to 1. (EC Section 46120[b][2][D]). ELC supports the Transitional Kindergarten (TK) students and Kindergarten (K) students in need of a nine hour program at all 35 elementary school sites in the District.

Recruitment & Training

The ELC staff serving the TK/K programs have prior work experience with the age group and/or have obtained Early Childhood Education credits. The staff participates monthly in targeted training courses to support their understanding and implementation of developmentally appropriate practices.

Curriculum

The ELC staff collaborate closely with our California State Preschool Programs team, site TK/K teacher teams and site administration to develop experiences that meet the unique needs of Transitional Kindergarten and Kindergarten students.

Participating students will receive academic support with early literacy development, hands-on art projects, and develop their social-emotional skills.

EC Section 46120(b)(2):

[LEAs] operating expanded learning opportunities programs may operate a before school component of a program, an after-school component of a program, or both the before and after school components of a program, on one or multiple school sites, and shall comply with subdivisions (c), (d), and (g) of Section 8482.3, including the development of a program plan based on the following;

[LEAs] shall agree that snacks made available through a program shall conform to the nutrition standards in Article 2.5 (commencing with Section 49430) of Chapter 9 of Part 27 of Division 4 of Title 2.

[LEAs] shall agree that meals made available through a program shall conform to the nutrition standards of the United States Department of

Agriculture's at-risk afterschool meal component of the Child and Adult Care Food Program (42 United States Code [U.S.C.] Section 1766).

EC Section 8482.6:

Every pupil attending a school operating a program . . . is eligible to participate in the program, subject to program capacity. A program established . . . may charge family fees. Programs that charge family fees shall waive the cost of these fees for pupils who are eligible for free or reduced-price meals, for a child that is a homeless youth, as defined by the federal McKinney-Vento Homeless Assistance Act (42 U.S.C. Section 11434a), or for a child who the program knows is in foster care. A program that charges family fees shall schedule fees on a sliding scale that considers family income and ability to pay.
