2. Center for Advanced Research and Technology (CART) (Sandoval)

The CART Board of Directors met on March 14, immediately followed by the annual CART/CUSD/FUSD Joint Board of Directors Meeting. The CART Board of Directors meeting included the swearing-in ceremony of Christopher De La Cerda as the Fresno Unified School District Board Representative to the CART Board, and a 2nd interim budget report presented by CUSD Director of Budget and Finance Sue Rutledge.

The highlight of the CART/CUSD/FUSD Joint Board of Directors meeting was the CART Alumni Panel, during which former students shared their experiences at the school and how their CART education helped them to obtain their career goals. Finally, a CART Year-in-Review presentation was given by CEO Rick Watson and Dean of Curriculum and Instruction Lisa Hansen, Ed.D.

3. Curriculum (Budd, Hovsepian, Van Volkinburg)

At the March 15 Curriculum Board Subcommittee meeting, members reviewed two new course proposals for the 2017-18 school year. One of the courses, Rehabilitation Therapy Careers, was before the Board for action at this March 22 meeting, and the other course, Cybersecurity I, will be presented to Board members for information at their April 5 meeting. The Cybersecurity class, which will provide students with a certification upon completion, meets a significant need in the workforce for networking and cybersecurity technicians. Also discussed was the possibility of reinstating the position of Coordinator of Community Relations, which could potentially be funded through the Local Control Accountability Plan (LCAP). Subcommittee members also had the opportunity to review the most up-to-date draft of the LCAP in anticipation of the LCAP Parent Advisory Committee meeting to be held Monday, March 27. Following this meeting, the LCAP will again be revised to incorporate community feedback and will be reviewed by Curriculum Board Subcommittee members at a future meeting. Potential new textbooks were discussed, including those that would be used for the District's 17 new Career Technical Education (CTE) courses. Parents and industry experts are looking at these textbooks to ensure they meet class needs, while all families and community members had an opportunity to review the books as well at Clovis Unified's Community Book Fair held at the Clovis Veterans Memorial District on March 21. Several CTE and Preschool grants were discussed. Two important surveys were recently administered around the District. Parents were asked to complete the annual SART survey, with all of the forms available online to all parents for the first time. Additionally, students in grades four through 11 were asked to give their feedback and opinions through a new survey piloted this year. Finally, Subcommittee members looked at potential changes to Administrative Regulation No. 2202 – Student Residence and Board Policy No. 2203 – Entrance Age.

**4.** Facilities (Fogg, Heryford, Sandoval)

At the March 15 Facilities Board Subcommittee meeting, members reviewed design, bid and construction reports, change order reports, and bond measure finance reports. Members heard about updates and remodeling needs at the District's newly acquired Professional Learning Center (PLC) building and Employee Health Center. An update was given on water infrastructure

adjustments in the South East Development Area (SEDA) that may affect residential development around the site proposed to house the District's sixth comprehensive high school. Finally, asset management for Clovis Unified's phase II solar installation project was discussed including the possibility of utilizing a third party to provide asset management services for the District's phase II solar panels to ensure the panels are producing optimally, thus increasing savings.

# Summary of Changes from the 2016-2019 to 2017-2020

## Local Control Accountability Plan (LCAP)

Listed below is a summary of the proposed additions to the 2017-2020 LCAP as compared to the prior year LCAP. The LCAP is a three-year plan that focuses on the current year (2016-17) and the coming school year (2017-18).

#### Funding and Budget:

- Supplemental Funding
  - 2016-17 42.08% unduplicated students compared to 2017-18 projection of 42.33% unduplicated students
  - o The 2016-17 Supplemental Fund Allocation was \$4,632,088 in new funding compared to the estimated 2017-18 Supplemental Fund Allocation of \$1,243,285 in new funding.

#### Recommended additions to the 2017-2020 LCAP Actions and Services include:

- Additional School Resource Officer support for elementary and evening coverage.
- Additional funding for translation services.
- Additional psychologist support at the secondary sites to support students' social and emotional well-being.
- Re-establish the Coordinator of Community Relations position to support the Dignity and Respect Initiative for students, staff, and community.
- Additional psychologist and behavior intervention assistants at the elementary level to increase levels of behavioral, social, and emotional support.
- Reduce class sizes at our Title One schools.
- Provide a lead psychologist to oversee and provide leadership of the Comprehensive Wellness Plan that will further support students' social and emotional well-being.

It is recommended that all existing Actions and Services remain in place.

#### **Evaluation Component:**

• The evaluation section now includes the new California Assessment of Student Performance and Progress (CAASPP) data and other state indicator performance level data from the CA School Dashboard. The state indicators are: Suspension Rate (K-12), English Learner Progress (K-12), Graduation Rate (9-12), English Language Arts (3-8), and Mathematics (3-8). Results will be available for all student groups including: English Learners, Foster Youth, Homeless, Socioeconomically Disadvantaged, Students with Disabilities, American Indian, Asian, African American, Filipino, Hispanic, Pacific Islander, Two or More Races and White.

## LCAP Planning

#### The LCAP is:

- A three-year plan that was first adopted in June 2014 describing how we continuously improve the quality and quantity of services to targeted students.
- Annually updated and modified based on the evaluation of actions, services, and stakeholder feedback.
- A partnership between the district and schools which includes, students, parents, community members and employees.


Each year, the Governing Board must take action on the updated LCAP at its June meeting (at the same time the annual budget is adopted).

The adopted LCAP will be a three-year plan (2017-2020) which includes both the Local Control Funding Formula (LCFF) base and supplemental funds used to increase the quality and quantity of services to students. The plan represents an extensive feedback gathering process and takes into account what stakeholders have identified as the actions and resources they believe will positively impact all students.

## What Impact Does the Local Control Funding Formula Have on Clovis Unified?

With a 43.16% three year average of eligible students (unduplicated count of Foster Youth, English Learners and Low Income students), Clovis Unified is expected to receive the following Supplemental dollars in 2017-18:

New Supplemental Grant Dollars: \$ 1,243,285

We do not qualify for Concentration Grant funds (additional dollars available for school districts with over 55% of their student populations falling into these categories).

- The Local Control Accountability Plan focuses on the use of supplemental dollars to improve services to at risk students. The state also expects to see a significant portion of our total budget accounted for in the LCAP.
- The estimates of new supplemental and base dollars is the result of a projected COLA of 1.48%, 23.67%
   LCFF gap closure, and 438 average daily attendance growth to the district during the 2017-18 fiscal year.

Title: Sierra Outdoor School – Fee Increase for 2017-18

#### **RECOMMENDATION:**

Approve a proposed fee increase for Sierra Outdoor School starting in the 2017-18 school year for all schools.

#### **DISCUSSION:**

The Sierra Outdoor School (SOS) provides outdoor educational programs to both Clovis Unified schools and non-Clovis Unified schools. The funding to operate SOS comes primarily from the per-student fee to attend. Educational Services continually evaluates the fiscal viability of SOS to ensure that it has little or no impact on the District's General Fund Budget.

SOS prides itself on providing a quality outdoor educational experience that is affordable for all children. In order to cover increases in multiple operational expenses, SOS is recommending a modest fee increase that will enable the program to continue to be self-sustaining and funded by fees charged.

The attached survey of similar programs demonstrates that proposed increases will continue to keep SOS' costs competitive with or lower than comparable programs. Sierra Outdoor School has exercised caution, and will continue to do so, in recommending increases in attendance fees.

In 2015, the Governing Board approved a 6% fee increase for non-Clovis Unified schools, which accounts for about 75% of all SOS revenue. The last fee increase for Clovis Unified schools was in 2009-10 when an \$8.00 per-student increase was approved.

SOS is recommending a 7% increase for all Clovis Unified schools and non-Clovis Unified schools to allow SOS to operate efficiently while being fiscally responsible as a self-sustaining program. If approved, the increase would take effect for the 2017-18 school year. The increases would be evaluated during the 2017-18 school year.

#### FISCAL IMPACT/FUNDING SOURCE:

It is projected that implementation of the recommended fee increase will generate enough revenue to cover increases in expenses while maintaining a surplus of \$15,224.

#### Sierra Outdoor School Fee Increase Proposal

**Rationale**: Sierra Outdoor School prides itself on providing a quality outdoor educational experience that is affordable for all children. Due to the increases in expenses such as PERS, minimum wage, cost of goods/services, additional staffing needs due to growth and step/column increases, SOS is asking for a modest fee increase to cover these expenses. This fee increase is strictly being recommended so that it covers increased expenses. SOS will continue to work on being a self-sustaining program that is 100% funded by the fees generated. The last time the District increased fees for non-CUSD schools was in 2015 (6% increase) and this accounts for about 75% of all revenue for SOS. The last fee increase for CUSD schools was in 2009-10 at an \$8.00 increase.

The following information listed below outlines current fees for programs operated by County Offices of Education, Clovis Unified School District, and one private organization (Nature Bridge) in Yosemite. The purpose is to demonstrate what the market currently looks like, and will bear, as well as to demonstrate the value of SOS' program when compared with other programs. Sierra Outdoor School fees, for both CUSD and non-CUSD schools, are highlighted. The difference between what was charged last year between non-CUSD schools and CUSD schools was \$46,000.00. Figure 1 shows the *current* fees for the listed programs.

**Figure 1** shows that Nature Bridge is at the top of the comparison market, with Merced COE at the bottom of the market. It should be noted that Merced's lowest fees are on weekends. Additionally, Merced requires teachers to teach during their stay. Sierra Outdoor School's fee for CUSD schools comes in a close second for being the lowest priced program. \*These comparisons do not take into account if there are additional fee increases for minimum wage, cost of goods/services, etc., for the outside organizations in future years.

**Figure 2** represents fee increases for non-CUSD schools at 5% and 7%. In order for SOS to keep pace with cost increases in salaries and benefits as well as food, utilities, maintenance, PERS, and program supplies, periodic fee increases must occur. 2016-17 fees are highlighted. It should be noted that a 5% increase would not cover additional expenses and SOS' program would be potentially running in the deficit. A modest 7% increase (for both CUSD and non-CUSD schools) would allow the program to grow and cover all necessary additional expenses.

**Figure 3** represents current fees for Clovis Unified schools with increases at 5% and 7%. As mentioned previously, the fees for CUSD schools have not been raised since the 2009-10 school year. While the percentages on this table will not bring non-CUSD and CUSD schools into equitable fees, the increases will help Sierra Outdoor School keep moving toward generating higher revenue while allowing CUSD schools to benefit from a Clovis Unified-owned facility.

Using our revenue projection for the 2016-17 school year, potential 2017-18 school year increases at 5% and 7% have been calculated and are listed below. These calculations show that the 5% fee increase would leave a \$29,053 deficit, whereas the 7% fee increase covers all increased expenses and leaves a \$15,224 surplus.

A 7% increase is recommended for all CUSD and non-CUSD schools to allow SOS to operate efficiently and to operate in the positive, financially. This proposal is based off of the need to cover increased expenses in PERS, minimum wage, cost of goods/services, step and column, and the increased staffing to accommodate growth at SOS. This change would be for the 2017-18 school year. These increases will be evaluated during the 2017-18 school year, and any future recommendations, if needed, would be made at a later time. The goal is to be as efficient as possible to make SOS' programs affordable for all. The focus is to keep the cost of SOS' programs as low as possible while providing an exceptional experience that students will never forget.

Section 48800 of the California Education Code allows school district Governing Boards to authorize students to attend public higher education classes if students would benefit from the advanced scholastic or vocational training offered by public community colleges, the State University system or the University of California system. School districts receive full average daily attendance (ADA) credit for students participating in this program if the student is in his/her regular high school for at least 240 minutes per day or receives 3/4 of a full average daily attendance if students enrolled in this program attend their regular high school for at least 180 minutes per day.

Students at Buchanan, Clovis, Clovis East, Clovis North and Clovis West high schools have participated in this program for the past several years. In order for the District to claim this additional ADA, audit forms will be required to verify that all students participating in the Concurrent Public Higher Education Program summarized above are approved by the Governing Board.

A copy of the 2016-17 concurrent enrollment for the comprehensive high schools will be provided to all Governing Board members prior to the April 26, 2017, Board meeting.

The focus is on meeting the needs of students who traditionally have been underrepresented in higher education.

The contract with AVID provides teachers with research-based strategies and curriculum at all secondary schools for grades 7-12, as well as at Jefferson, Pinedale, Weldon, Miramonte and Tarpey elementary schools.

The contract also provides annual District leadership training, staff training and summer institute opportunities, which are considered by many to be some of the best education-related professional learning in the Nation. AVID's impact goes beyond the AVID elective and uses academic strategies school-wide such as writing to learn, inquiry, collaboration, organizational skills and critical reading, as trained teachers use AVID library/materials and methodologies in their specialized content areas.

**Title:** Annual Agreement with America's Kids Swim School Learn-to-Swim Program for 2017-18

#### RECOMMENDATION:

Authorize the Superintendent or designee to renew an agreement with America's Kids Swim School to partner with the Clovis Swim Club to manage the administration of existing Swim Club Learn-to-Swim lessons, and provide a resource for future enrollees in the Clovis Swim Club Competitive Program.

#### **DISCUSSION:**

On April 25, 2007, the Governing Board approved an agreement with SwimAmerica (now America's Kids Swim School) to assume responsibility for the management and administration of the existing age 10 and under Learn-to-Swim Program. America's Kids Swim School (AKSS) operates a nationally recognized Learn-to-Swim curriculum developed by professional swim coaches. Under the proposed agreement, AKSS will utilize District pool facilities to operate Learn-to-Swim classes during summer 2017, in turn, providing long-term class opportunities through the Clovis Swim Club due to facility limitations during winter months. AKSS operates an indoor pool facility at Willow and Nees avenues. Included in the agreement is a requirement that AKSS will direct Learn-to-Swim graduates to Clovis Swim Club to begin their competitive swimming experience. If approved by the Board, the new agreement will be effective May 1, 2017, to May 1, 2018.

AKSS will provide Clovis Unified a full accounting, and will pay the District a 75% share of the net profits earned by AKSS from the lesson revenue, up to \$40,000. Net profits accruing to AKSS in excess of \$40,000 will be split with 25% to the District, and 75% to AKSS. Net profits shall be calculated from the total lesson and registration fee income minus all program costs including insurance, administrative staff/site-supervisor/coaches' salaries, t-shirts, wristbands and taxes.

AKSS will invest and pay the following expenses: Certification Training costs for all swim coaches and instructors, payment for all America's Kids Swim School Site-Supervisor Training, Level 1 and 2 American Swimming Coaches Association Certification, and ongoing coach/instructor continuing education, background check, and fingerprinting costs, which shall not be considered program costs and will not be deducted in calculating net profits.

#### **DISCUSSION:**

Each year, Clovis Unified receives Migrant Education Funds. The purpose of the Migrant Education Program (MEP) is to support high-quality and comprehensive educational programs for migrant children and their families in order to reduce the educational disruption and other issues that result from repeated moves. Funds and services are designed to assist in designing and creating migrant programs to better enable migrant students to achieve high standards.

CUSD currently serves 44 migrant students in grades K-12 and their families (27 are in grades K-6, four are in grades 7 and 8, and 13 are in grades 9-12). Annually, Clovis Unified is required by the Fresno County Office of Education and the California Department of Education to develop and submit its DSA in collaboration with our Migrant Parent Advisory Committee. The DSA is the District's comprehensive plan to address educational needs and establish specific goals and objectives to support student achievement, health and wellness and parent education of our migrant students and their families. The DSA is an ongoing process of comprehensive data analysis used to refine objectives each year to determine successful practices and programs to ensure migrant students receive full and appropriate opportunities to meet the same challenging state standards all children are expected to meet.

The DSA is to be certified by the Fresno County Office of Education Migrant Department by May 2017. For the 2017-18 school year, there are two (2) projected allocations consisting of:

- Regular School Year Allocation: \$26,500
- Summer Allocation: \$9,170

This projection is subject to the final award amount announced later in the fiscal year.

#### STUDENT SERVICES RIGHTS AND RESPONSIBILITIES

Admissions Residency and Attendance
ATTENDANCE REQUIREMENTS

PURPOSE: To assure compliance with appropriate sections of the California Education

Code pertaining to entrance to kindergarten, transitional kindergarten, first

grade, and transfer from kindergarten to first grade.

#### A. ADMISSION TO KINDERGARTEN AND TRANSITIONAL KINDERGARTEN

1. A child shall be admitted to kindergarten during the first school month if the child attains the age of five on or before September 1 of that school year.

- 2. A child shall be admitted to a transitional kindergarten program if the child attains the age of five between September 2 and December 2 of that school year.
- 3. Transitional kindergarten is the first year of a two year kindergarten program that uses a modified kindergarten curriculum that is age and developmentally appropriate. Students who enroll in transitional kindergarten will be admitted to kindergarten the following school year.

#### B. EARLY ADMISSION TO KINDERGARTEN OR TRANSITIONAL KINDERGARTEN

Parent(s)/guardian(s) requesting to enroll a student in kindergarten or transitional kindergarten earlier than the State guidelines allow, must initiate an appointment with the principal of their student's neighborhood school and present compelling evidence for their request. Compelling evidence may be comprised of academic and psychological documentation that supports the parents'/guardians' assertion that their child is prepared to enter kindergarten—or transitional kindergarten. Should the principal find merit in the request, the principal will request that the school psychologist and a kindergarten teacher conduct an evaluation of the student's academic, social and physical readiness. The results of this evaluation will form the site's rationale for supporting or denying the request for early admission and be provided to the parents/guardians and Area Assistant Superintendent in writing.

Should the school site support early admission, the Area Assistant Superintendent will present the principal's written support to the Clovis Unified School District Governing Board for approval.

All requests for early enrollment in kindergarten or transitional kindergarten must be approved by the Governing Board.

### **Board Policy**

### CLOVIS UNIFIED SCHOOL DISTRICT

#### C. **PROMOTION TRANSFER** FROM KINDERGARTEN TO FIRST GRADE

- 1. It is a policy of the Board that a child who has been lawfully admitted to a public school –or private kindergarten in California and who has attained at least five years of age, may be placed in the first grade at the discretion of the principal of an elementary school operated by the District if it is determined by the principal that the child is ready for first grade work. Parent(s)/guardian(s) requesting that their student be enrolled in first grade before completing kindergarten, must initiate an appointment with the principal of their student's school and provide compelling evidence for their request. Compelling evidence may be comprised of academic and psychological documentation that supports the parents'/guardians' assertion that their child is prepared to enter first grade.
- **2.** The elementary school principal shall assure that a kindergarten student considered for placement in the first grade shall meet the following minimum criteria:
  - a. The kindergarten student has attended a public school kindergarten for a sufficient time to allow an evaluation of the student's academic ability. A kindergarten teacher shall retain a student a minimum of two weeks and not more than four weeks in a regular kindergarten classroom.
  - b. The child is in the upper 5% of his or her grouppeers in terms of general mental abilityacademic performance. All students who appear eligible (either by parent request, or teacher observations) shall be given a group or individual readiness test designated by the District within the first two weeks after the opening of school. The District may require other tests as deemed necessary, the expense of which will be borne by the parents. The results of these tests will form the site's rationale for supporting or denying the request for early promotion admission and be provided to the parents/guardians and Area Assistant Superintendent in writing.
  - c. **The It—child** shall —also—be required that the child—exhibit advanced physical development and social maturity at the time of the request. Further, it should be reasonably expected that these advanced characteristics will be maintained as the child advances through the grades.
  - d. The parent shall filesign a written statementacknowledgement approving placement in the first grade after a personal conference with the principal and the teacher.

## CLOVIS UNIFIED SCHOOL DISTRICT

#### D. ENTRANCE TO FIRST GRADE

1. A child who, consistent with Section 48000 of the California Education Code, has been admitted to a kindergarten maintained by a private or a public school in California or any

other state, and who has completed one school year therein, shall be admitted to the first grade of an elementary school, unless the parent or guardian of the child and the school district agree that the child may be retained continue in kindergarten for no more than an additional school year.

A year of attendance in kindergarten does not in itself qualify a child for admission to the first grade, unless the child was properly eligible under age requirements of Section 48000 of the California Education Code at the time the child began the year of kindergarten.

2. A child who is six years of age can enter school at any time.
