2. Center for Advanced Research and Technology (CART) (Sandoval)

During the CART Board of Directors' April 18 meeting, CEO Rick Watson shared upcoming end-of-year events including the CART Scholarship Awards Ceremony on May 8 and Spring Showcase on May 16. Also discussed was the 2017-18 CART academic calendar, which will again be a blend of the Fresno Unified and Clovis Unified school calendars. CART's new Strategic Plan is still under development, but is expected to be finalized soon. The Curriculum Board Subcommittee met on April 19 at the Professional Learning Center. Members reviewed the State's new data dashboard that shows Clovis Unified's testing results. A student achievement Board workshop will be held in the fall to explain the new results reporting process. The proposed 2017-18 textbooks that will come before the Board members for action at their May 10 meeting were reviewed, and the Curriculum, Instruction and Accountability Department's proposed job description for the new position of Director of Digital and Multimedia Learning was distributed. Also discussed were online modules created by the Curriculum Department related to student internet safety with lessons and information for teachers and parents. Finally, members reviewed Board Policy No. 3403 – *Placement in Ninth Grade Mathematics Courses* and the corresponding Exhibit, and discussed options parents can pursue to place their students in a higher level mathematics course even if they do not test into that level.

4. Facilities (Fogg, Heryford, Sandoval)

During the Facilities Board Subcommittee meeting on April 19, members reviewed in-depth the design, bid and construction reports, change order reports, and bond measure finance reports. Members discussed the process of officially naming the District's newly acquired Professional Learning Center (PLC) building and Employee Health Center. An update on developer fees was shared. Finally, the subcommittee members were given a tree replacement report and learned that the District loses more trees due to natural causes such as disease and bad weather than to those that have been removed for Clovis Unified's solar installation project. Plans to replace the

lost trees were discussed.

#### SCHOOL COMMUNITY RELATIONS Community Relations VOLUNTEER ASSISTANCE

# PURPOSE: To encourage community members to enrich the educational experience of students while strengthening the schools' relationships with the community.

The Governing Board encourages parents/guardians and other members of the community to share their time, knowledge and abilities with our students. Community volunteers in our schools enrich the educational program, contribute to school safety, and strengthen our schools' relationships with the community. The Board encourages principals to develop a means for recognizing the contributions of each school's volunteers.

No person has any right to provide, nor is the District obligated to accept, volunteer services. A person also has no right to a particular volunteer assignment, event, location or classroom. Volunteers shall act in accordance with state and federal laws, District policies and regulations, including but not limited to Board Policy No. 9202 (School Visitors) and Board Policy No. 9210 (Civility Policy), and school rules.

Volunteer maintenance work shall be limited to those projects that do not replace the normal maintenance duties of classified staff. Volunteer aides shall not be used to assist certificated staff in performing teaching or administrative responsibilities in place of regularly authorized classified employees who have been laid off.

The Board prohibits harassment of any volunteer on the basis of race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status. (Government Code 12940(j))

The Superintendent or designee shall establish administrative regulations setting forth procedures to protect the safety of students and adults in accordance with applicable laws, including requirements for recruiting, screening and placing volunteers.

The Board desires to provide a safe environment for volunteers and minimize the district's exposure to liability. Upon the adoption of a resolution by the Board, volunteers shall be entitled to workers' compensation benefits for any injury sustained while engaged in the performance of service for the District. (Labor Code 3364.5)

#### SCHOOL COMMUNITY RELATIONS Community Relations VOLUNTEER ASSISTANCE

#### Duties of Volunteers

- 1. Volunteers may assist certificated personnel in the performance of their duties, supervision of students, and instructional tasks which, in the judgment of the certificated personnel to whom the volunteer is assigned, may be performed by a person not certified as a classroom teacher. These duties shall not include assignment of grades to students.
- 2. Volunteers may supervise students during lunch and/or breakfast periods. They may also serve as non-teaching aides under the immediate supervision and direction of certificated personnel and perform non-instructional work.
- 3. Volunteers may work on short-term facilities projects as approved by the Superintendent or designee, and authorized by the site principal.

#### **Qualifications of Volunteers**

- 1. Volunteers providing supervision or instruction of students shall provide evidence of basic skills proficiency, including previous, related experience.
- 2. The Superintendent or designee may refuse to allow a person to volunteer, or limit the activities of a volunteer who has been found guilty or pled guilty to any criminal offense in a court of law.
- 3. Prior to parent or other volunteer participation in student programs or activities, the principal or his/her designee must check Megan's Law or other appropriate law enforcement registries to ensure that individuals have not been registered as sex offenders. A person who is required to register as a sex offender pursuant to Penal Code Section 290 shall not serve as a volunteer in classrooms or other situations where the person will or **may**is likely to have contact with students.
- 4. Volunteers shall be fingerprinted only when placed in situations in which they directly supervise students without a paid District employee present or volunteer on a one-time basis to transport or chaperone students with appropriate parent permission (i.e. off-campus activities and/or programs such as Destination Imagination, Robotics, etc. or any activity without direct supervision by a paid District employee). This requirement shall not apply to volunteer supervisors for breakfast, lunch, or other nutritional periods or to volunteer nonteaching aides under the immediate supervision and direction of certificated personnel pursuant to Education code 35021, including parents/guardians volunteering in a classroom or on a field trip or community members providing noninstuctional services. (Education code 49024(c))
- 5. No volunteer shall be assigned to provide supervision or instruction of students unless he/she has submitted evidence of an examination within the past 60 days to determine that he/she is free of active tuberculosis. A person who tests positive for tuberculosis may not serve as a volunteer. Volunteers whose skin test is negative shall thereafter be required to take a tuberculosis test every four years. The Superintendent or designee may exempt from tuberculosis testing requirements those volunteers who serve less than a school year and

whose functions do not require frequent or prolonged contact with students. In situations in which volunteers must be fingerprinted or tested for tuberculosis, the District may collect a reasonable fee not to exceed the actual costs incurred by the agency. Upon initial volunteer assignment, a volunteer shall have on file with the school a certificate showing that he/she has submitted to a tuberculosis risk assessment and, if tuberculosis risk factors were identified, was examined and found to be free of infectious tuberculosis. (Education Code 49406(m)) The Superintendent or designee may exempt from the tuberculosis risk assessment and/or examination those volunteers whose functions do not require frequent or prolonged contact with students. (Education Code 49406(m))

- 6. Volunteers in a District preschool who provides care and supervision to children at the preschool shall, unless exempted by law, be immunized against influenza, pertussis, and measles in accordance with Health and Safety Code <u>1596.7995</u>. Documentation of required immunizations, or applicable exemptions, shall be maintained by the District. (Health and Safety Code <u>1596.7995</u>)
- **7. 76**. Volunteers shall be provided with information regarding state and federal laws and all policies and regulations of the Governing Board, including rules and regulations of the Volunteer Program. All volunteers shall be required to complete and submit the "Volunteer Application Form 9212" to the appropriate school site prior to providing service to schools and/or related programs.
- 8. 87. Effective July 1, 2010, volunteers who will be transporting students must also submit Form 8302-1 Private Vehicle Driver Application, and comply with the requirements of Board Policy and Administrative Regulation No. 8302 Transportation of Students by Private Vehicle.
- **9. 98**. Volunteers will be provided, and shall wear in plain view at all times while engaged in volunteer activities, an identification card.

Approve the District's annual submission of a waiver request to the California State Board of Education, which would allow Kindergarten instructional minutes at some school sites to vary from Transitional Kindergarten instructional minutes at those same sites, as submitted.

#### **DISCUSSION:**

Clovis Unified School District offers Kindergarten and Transitional Kindergarten (TK) in its elementary school programs. The TK program provides students with developmentally appropriate, experiential activities and helps prepare them for the more academically rigorous second year of Kindergarten.

As part of the early primary program, some elementary schools within Clovis Unified offer extended day programs for Kindergarten students as outlined in Board Policy No. 1302. These schools choose to offer extended day Kindergarten programs based on the needs of their student population.

However, according to the law, Kindergarten and Transitional Kindergarten programs must be equal in instructional minutes, unless a waiver of this provision is granted through the California State Board of Education. Requiring TK students to attend school for an extended day based on the minutes of the Kindergarten program would not be in the best educational interest of Clovis Unified's youngest students.

Thus, the District is seeking a waiver that would allow TK programs at selected school sites to operate with instructional minutes that are less than those selected school sites' extended Kindergarten programs.

While we recognize the use of technology is increasing, it is still simply a tool for instruction and does not take the place of a teacher and quality instruction. Therefore, it is critically important that careful effort is taken to ensure effective use of technology to support classroom learning.

Additionally, as curriculum materials include an increasing number of technology resources and teachers explore the many instructional apps available, a need exists to identify best practices and the resources most likely to positively impact student learning.

The Director of Digital and Multimedia Learning will provide the needed support to guide Clovis Unified to the next level of academic excellence in the use of instructional technology. It is anticipated that the oversight provided by this position will result in cost savings to the District by leveraging District-wide pricing rather than individual school site pricing on identified technology.

A copy of the proposed job description, which was reviewed in the April meeting of the Curriculum Board Subcommittee, is attached.

National IPA recently merged with The Cooperative Purchasing Network (TCPN) and offers additional purchasing resources.

#### DISCUSSION:

National IPA and TCPN awarded piggyback bids for the purchase of various items at steeply discounted rates. Many contracts are valid through 2018. Current and subsequent orders would only be placed against these bids as long as it remains in the best interest of the District. Section 20118 of the California Public Contract Code provides that the Governing Board of a school district may authorize the purchase of equipment, materials and supplies from another public corporation or agency without advertising for bids if the other public corporation or agency has complied with all Public Contract Codes regarding the purchase of similar equipment, materials and supplies.

Both National IPA and TCPN competitively bid for many types of services and supply contracts with organizations throughout the country. The District can utilize National IPA and TCPN Contract R142203 – MeTeor Education LLC for future District needs. MeTeor Education LLC, formerly known as Contrax Furnishings, has provided quality product and service to the District in the past. The District can also utilize Office Depot Contracts R141605, R141706 and R142212 for ongoing District needs.

Purchasing staff will continue to monitor pricing trends and available contracts to determine which contracts best meet the needs of the District.

Adopt Resolution No. 3591 to allow Clovis Unified School District to report directly to California State Teachers' Retirement System (CalSTRS).

#### DISCUSSION:

School district employers report member and pension contribution data and remit contributions to CalSTRS using a hierarchical reporting model wherein a school district reports retirement information and remits contributions to its respective county superintendent of schools. The county then compiles and submits the information and remits the contributions to CalSTRS. In becoming a direct reporter, the District will no longer report through the Fresno County Superintendent of Schools, but will report directly to CalSTRS.

Anticipated benefits of becoming a direct reporter include improved process efficiency for the District, county superintendent of schools and CalSTRS. This process will allow for increased effectiveness and efficiency within the District's Payroll Department by allowing additional days each month to process and reconcile the contribution data. As a direct reporter, the District will be CalSTRS' sole point of contact for data and contributions related to our employees.

CalSTRS limits the ability to become a direct reporter to districts who have met strict criteria set forth by CaISTRS regulations, and that have demonstrated knowledge and the ability to execute the laws and regulations related to reporting CaISTRS contributions. A clean CaISTRS audit and the District's three-year clean audit streak contributed to CaISTRS' tentative acceptance of the District's request to become a direct reporter.

WHEREAS, the Clovis Unified School District (hereinafter "District") desires to become a direct report source that reports Defined Benefit Plan contributions data and remittance directly to CalSTRS; and

**WHEREAS**, if at any time, CalSTRS terminates the District as a direct report, the Fresno County Superintendent of Schools (FCSS) will immediately resume reporting contribution data and remittance for the District to CalSTRS;

 a. If District is terminated as a direct report, Fresno County Superintendent of Schools (FCSS) shall be responsible for submitting or remitting any missed reports, adjustments, contributions, penalties, and interest associated with the time period that the district was a direct report.

THEREFORE, BE IT RESOLVED that the Governing Board does hereby:

- I. Affirm that on May 24, 2017 the District hereby elects to become a direct reporter for CalSTRS effective on July 1, 2017; and
- II. Affirm the District met CalSTRS eligibility requirements, including:
  - b. Is fiscally independent per California Education Code section 42647;
  - c. Has a payroll system independent of the County Office;
  - d. Has the ability to be in full compliance with the F496 File Specifications;
  - e. Is responsible for submitting contribution data and remitting

contributions in accordance with the Teachers' Retirement Law;

- f. Is responsible for submitting contribution data and remitting contributions for all adjustments to contributions that relate to service performed prior to the effective date of the direct reporting relationship as requested by the system or as identified by the District;
- g. Is responsible for payment of any penalty assessments for contributions and data submitted as a direct report on or after the effective date of the direct reporting relationship;
- Is responsible for submitting all contribution data and remitting all contributions on and after the effective date of becoming a direct report;
- Has been issued an unqualified opinion on its annual financial audit and the management letter does not contain any material weaknesses/misstatements and significant deficiencies with its internal controls within the last five years;
- j. Has not been on probationary accreditation status nor had its accreditation status withheld by the most current accreditation body sanctioned by the California Department of Education in the last five fiscal years;
- k. Shall notify the system within three business days if its payroll operations are no longer independent of the county or if its fiscally accountable status or fiscal independence is revoked.
- Shall notify the system within three business days if it is placed on a one-year probationary accreditation status or has its accreditation status withheld or an equivalent status by the accrediting body.
- m. May terminate the direct reporting relationship only when the system, the District, and FCSS have agreed to the employer terminating the relationship.

THERFORE, BE IT FURTHER RESOVLED that the Clovis Unified School

District elected to be a CalSTRS direct report source as of July 1, 2017.
