At the May 9 Budget Board Subcommittee meeting, members discussed the District's workers compensation program. Business Services and insurance provider ASCIP are reviewing causes of claims and the severity of injuries in Clovis Unified as compared to other California districts to gain perspective on the District's effectiveness in risk management. They are also reviewing other districts' best practices to reduce claims that could potentially be integrated into Clovis Unified's practices. At the request of ASCIP, the District is piloting "Permission Click," an online program through which parents can complete permission slips for their students' fieldtrips, activities, etc. Subcommittee members recognized that, if the pilot period proves successful, subscribing to Permission Click could offer cost and time-saving benefits and efficiencies. Organizational Capacity was discussed including adding 14 teachers through LCAP funds, 17 due to growth and 17 for class size reduction at the elementary level. Members are anticipating the upcoming release of the Governor's May Revise Budget, which directly impacts Clovis Unified's budget.

2. Center for Advanced Research and Technology (CART) (Sandoval)

During the CART Board of Directors' May 9 meeting, members heard a special presentation on a Life Skills Initiative Proposal by members of the Fresno Business Council (FBC) who want to encourage local students to stay in the area to work, and to ensure they are well-prepared for the world of work. According to the FBC, area business owners have expressed that there is a need for young professionals to spend increased time learning "soft skills" such as effectively

preparing for job interviews, demonstrating professionalism and being strong team members. FBC members are proposing that CART initiate the instruction of some of these soft skills. CART Board members agreed to further discuss the topic at a fall workshop.

Beginning in the 2016-17 school year, high schools in Clovis Unified implemented protocols for mathematics placement of entering ninth grade students, pursuant to Board Policy No. 3403. The policy requires the Governing Board and the Superintendent or designee to annually review aggregate data to ensure that students who qualify to progress in mathematics courses are not held back in a disproportionate manner based on ethnicity, gender, or socioeconomic background. CUSD data shows that four (4) ninth grade students, out of 3,338, met at least one requirement to be enrolled in Math 1 but were enrolled, instead, in Foundations of Math 1. Based on results, the findings of disproportionate placement are insignificant. This is the first year that such a report is required and will, hereafter, become an annual report provided to the Governing Board each May.

Clovis Unified high schools will continue to implement the adopted protocol to ensure that ninth grade students progress appropriately in the mathematics course sequence for college and/or career readiness. In order to eliminate barriers to proper placement in the future, high schools will:

- Continue to train site administrators and counselors on math placement protocols and procedures;
- Increase Math 1 support classes for identified students who need additional time and instruction for success in math courses.

The written staff report detailing aggregate student placement data for placement in ninth grade mathematics courses is attached.



The SB 50 formula to determine Level II residential-only fees requires school districts to update the School Facilities Needs Analysis (SFNA) annually. Further, a copy of the SFNA must be submitted to all interested parties and jurisdictional agencies no later than thirty (30) days prior to the Public Hearing. Both National IPA and TCPN competitively bid for many types of services and supply contracts with organizations throughout the country. The District can utilize National IPA and TCPN Contract R142203 – MeTeor Education LLC for future District needs. MeTeor Education LLC, formerly known as Contrax Furnishings, has provided quality product and service to the District in the past. The District can also utilize Office Depot Contracts R141605, R141706 and R142212 for ongoing District needs.

Purchasing staff will continue to monitor pricing trends and available contracts to determine which contracts best meet the needs of the District.

School district employers report member and pension contribution data and remit contributions to CalSTRS using a hierarchical reporting model wherein a school district reports retirement information and remits contributions to its respective county superintendent of schools. The county then compiles and submits the information and remits the contributions to CalSTRS. In becoming a direct reporter, the District will no longer report through the Fresno County Superintendent of Schools, but will report directly to CalSTRS.

Anticipated benefits of becoming a direct reporter include improved process efficiency for the District, county superintendent of schools and CalSTRS. This process will allow for increased effectiveness and efficiency within the District's Payroll Department by allowing additional days each month to process and reconcile the contribution data. As a direct reporter, the District will be CalSTRS' sole point of contact for data and contributions related to our employees.

CalSTRS limits the ability to become a direct reporter to districts who have met strict criteria set forth by CalSTRS regulations, and that have demonstrated knowledge and the ability to execute the laws and regulations related to reporting CalSTRS contributions. A clean CalSTRS audit and the District's three-year clean audit streak contributed to CalSTRS' tentative acceptance of the District's request to become a direct reporter.

- k. Shall notify the system within three business days if its payroll operations are no longer independent of the county or if its fiscally accountable status or fiscal independence is revoked.
- Shall notify the system within three business days if it is placed on a one-year probationary accreditation status or has its accreditation status withheld or an equivalent status by the accrediting body.
- m. May terminate the direct reporting relationship only when the system, the District, and FCSS have agreed to the employer terminating the relationship.

Adopt Resolution No. 3592 regarding the annual Education Protection Account (EPA), as submitted.

DISCUSSION:

Proposition 30, the Schools and Local Public Safety Protection Act of 2012, approved by the voters on November 6, 2012, temporarily increases the State sales tax rate for all taxpayers, and the personal income tax rates for upper-income taxpayers. New revenues generated from Proposition 30 are deposited into a State account called the Education Protection Account (EPA). EPA funds are based on the proportionate share of the Statewide revenue amount. A corresponding reduction is made to the Local Education Agency's revenue equal to the amount of its EPA entitlement.

The District's State revenue is now comprised of three funding sources: State aid, EPA, and property taxes. The addition of a new funding source does not increase the District's revenue funding because the State aid revenue is decreased according to the amount of EPA funds received.

At the beginning of each year, the Department of Finance estimates the amount to be transferred into the EPA by districts. EPA revenue funds for Clovis Unified will be deposited into the newly created restricted resource 1400. These funds must, therefore, be accounted for under the following reporting requirements:

- 1. Each year the Governing Board must approve a spending plan for the EPA money (in the form of a Board resolution).
- 2. The EPA funds cannot be used for the salaries or benefits of administrators or for administrative costs.
- 3. The District must publish on its website the amount of EPA money received and how it was spent.
- 4. An annual audit will be required to verify that EPA funds were spent in accordance with the requirements of Proposition 30. The cost of this audit can be paid using EPA funds.
- 5. For fiscal years 2013-14 through 2018-19, the spending plan must be approved at the time the District's annual budget is adopted.

The temporary sales tax approved with the passage of Proposition 30 expired at the end of the 2016 calendar year. The personal income tax rates for upper-income taxpayers was due to expire at the end of the 2018 calendar year. On the November 2016 ballot, California voters approved Proposition 55, extending the Proposition 30 income tax increase for upper-income taxpayers through 2030.

This annual EPA resolution will be reviewed at the June 2017 Budget Board Subcommittee meeting. The proposed spending plan will be available at the June 14, 2017, Board meeting.

RESOLUTION REGARDING THE EDUCATION PROTECTION ACCOUNT (EPA)

WHEREAS, the voters approved Proposition 30 on November 6, 2012; and,

WHEREAS, Proposition 30 added Article XIII, Section 36 to the California Constitution effective November 7, 2012; and,

WHEREAS, the provisions of Article XIII, Section 36(e) create in the state General Fund, an Education Protection Account to receive and disburse the revenues derived from the incremental increases in taxes imposed by Article XIII, Section 36(f); and,

WHEREAS, before June 30th of each year, the Director of Finance shall estimate the total amount of additional revenues, less refunds that will be derived from the incremental increases in tax rates made pursuant to Article XIII, Section 36(f) that will be available for transfer into the Education Protection Account during the next fiscal year; and,

WHEREAS, if the sum determined by the State Controller is positive, the State Controller shall transfer the amount calculated into the Education Protection Account within ten (10) days preceding the end of the fiscal year; and,

WHEREAS, all monies in the Education Protection Account are hereby continuously appropriated for the support of school districts, county offices of education, charter schools, and community college districts; and,

WHEREAS, monies deposited in the Education Protection Account shall not be used to pay any costs incurred by the Legislature, the Governor, or any agency of state government; and,

WHEREAS, a community college district, county office of education, school district, or charter school shall have the sole authority to determine how the monies received from the Education Protection Account are spent in the school, or schools, within its jurisdiction; and,

WHEREAS, the Governing Board of the District shall make the spending determinations with respect to monies received from the Education Protection Account in open session of a public meeting of the Governing Board; and,

WHEREAS, the monies received from the Education Protection Account shall not be used for salaries or benefits for administrators, or any other administrative cost; and,

WHEREAS, each community college district, county office of education, school district, and charter school shall annually publish on its internet website an accounting of how much money was received from the Education Protection Account and how that money was spent; and,

WHEREAS, the annual independent financial and compliance audit required of community college districts, county offices of education, school districts and charter schools shall ascertain and verify whether the funds provided from the Education Protection Account have been properly disbursed and expended as required by Article XIII, Section 36 of the California Constitution; and,

WHEREAS, expenses incurred by community college districts, county offices of education, school districts, and charter schools must comply with the additional audit requirements of Article XIII, Section 36, and may be paid with funding from the Education Protection Act, and shall not be considered administrative costs for purposes of Article XIII, Section 36.

THEREFORE, BE IT RESOLVED that the monies received from the Education Protection Account shall be spent as required by Article XIII, Section 36, and the spending determinations on how the money will be spent shall be made in open session of a public meeting of the Governing Board of Clovis Unified School District;

BE IT ALSO RESOLVED that to be in compliance with Article XIII, Section 36(e), with the California Constitution, the Governing Board of the Clovis Unified School District has determined to spend the monies received from the Education Protection Act as attached.

Adopt Resolution No. 3593 approving the District's School Facilities Needs Analysis (SFNA) and establishing a Level II Alternative School Facilities (Developer) Fee of \$4.63 per square foot, effective July 1, 2017, as submitted.

DISCUSSION:

Since January 1987, school districts have had the authority to levy developer fees for all new construction within the school district including residential, commercial, and industrial development. The current maximum Level I fees school districts are authorized to levy are \$3.48 per square foot for residential development and \$0.56 per square foot for commercial and industrial development. At the current time, the District uses the higher Level II residential development fee of \$4.22 per square foot.

With the adoption of Senate Bill 50 (Leroy F. Greene School Facilities Act of 1998), school districts are authorized to levy a fee in excess of the amount identified above for new residential development with said fee to be based on State guidelines and the adoption of a school facilities needs analysis.

Based on State guidelines related to student generation rates from new development, projected new development during the upcoming five (5) years, State building costs, State approved school site acreage, estimated infrastructure costs for off-site, service-site, and utility improvements, the District's Level II alternative fee has been determined to be \$4.63 per square foot, which represents fifty percent (50%) of the facilities cost. It should be kept in mind that the costs included in the School Facilities Needs Analysis report reflect State guidelines and are not the "true" cost of building and occupying new schools in the District.

In addition to Level II school facility fees, SB 50 also authorized school districts to levy Level III alternative fees, which would cover one hundred percent (100%) of the cost of facilities. The Level III fee only becomes applicable if state funds for new facility construction are not available. On May 25, 2016, the State Allocations Board (SAB) made the certification that state funds were no longer available for new school construction, potentially allowing school districts to impose Level III fees. The implementation of Level III fees was thereafter delayed by a lawsuit, but an appellate court decision on November 1, 2016, cleared the way for eligible school districts to begin charging Level III fees. However, on November 8, 2016, Proposition 51 was passed by the voters, authorizing the issuance of \$9 billion in bonds for school construction and modernization, potentially making state funds available once again for school construction. As of now, however, the bonds authorized by Proposition 51 have not been issued or sold yet. In the

event that state school facility funding continues to be unavailable, the proposed resolution would authorize the Board to take action to impose Level III fees in the amount of \$9.26 per square foot of residential construction at any time upon providing thirty (30) days' notice to the building industry, the Cities of Clovis and Fresno, and the County of Fresno.

The report has been reviewed with the District's legal counsel and has been determined to meet all SB 50 requirements. Further, a copy of this report was sent to representatives of the City of Clovis, City of Fresno, and County of Fresno on April 26, 2017, in accordance with legal requirements. A copy was also provided to the local Building Industry Association. A copy is available for review through the Clovis Unified Facilities Office.

It is recommended that the Governing Board adopt Resolution No. 3593, a copy of which follows, that approves the District's School Facilities Needs Analysis and authorizes the implementation of the Level II fee of \$4.63 per square foot for all new residential development effective July 1, 2017.

RESOLUTION NO. 3593 BEFORE THE GOVERNING BOARD OF THE CLOVIS UNIFIED SCHOOL DISTRICT FRESNO COUNTY, CALIFORNIA

IN THE MATTER OF THE ADOPTION OF A SCHOOL FACILITIES NEEDS ANALYSIS AND THE ESTABLISHMENT OF ALTERNATIVE LEVEL II SCHOOL FACILITIES (DEVELOPER) FEES

WHEREAS, Education Code section 17620 authorizes school districts to impose certain fees as set forth in Government Code section 65995 et seq. to finance the construction and reconstruction of school facilities; and

WHEREAS, pursuant to Government Code section 65995 the District is currently levying its Level I fee at \$3.48 per square foot of assessable residential construction; and

WHEREAS, pursuant to Government Code section 65995.5, the District is currently levying a Level II fee of \$4.22 per square foot of assessable residential construction; and

WHEREAS, under Senate Bill 50 (SB 50), the Leroy F. Greene School Facilities Act of 1998 (Chapter 407, Statutes of 1998), Government Code section 65995.5 provides that in lieu of a residential fee imposed under Government Code section 65995, subdivision (b)(1), a school district may impose alternative fees on new residential construction in amounts calculated pursuant to Section 65995.5, subdivision (c), and 65995.7; and

WHEREAS, pursuant to Government Code section 65995.5, subdivision (b), in order to be eligible to impose fees in these alternative amounts, the school district is required to do all of the following: (1) make a timely application to the State Allocation Board (SAB) for new construction funding and be deemed by SAB to meet the eligibility requirements for new construction funding; (2) conduct and adopt a School Facilities Needs Analysis pursuant to Government Code section 65995.6; and (3) until January 1, 2000, satisfy at least one of the requirements set forth in subparagraphs (A) to (D) inclusive of Government Code section 65995.5, subdivision (b)(3), and after January 1, 2000, satisfy at least two of said requirements.

THEREFORE, BE IT RESOLVED that the Board makes the following findings:

1. The District has been determined by the State Allocation Board to meet the eligibility requirements for new construction funding.

2. The District has satisfied the requirements of Government Code section 65995.5, subdivision (b)(3)(C), in that the District has issued debt or incurred obligations for capital outlay in an amount equivalent to fifteen (15) percent of its local bonding capacity. The District has further satisfied the requirements of Government Code section 65995.5, subdivision (b)(3)(D), in that at least twenty (20) percent of the teaching stations within the District are relocatable classrooms.

3. The District has conducted a School Facilities Needs Analysis consistent with the requirements of Government Code section 65995.6 whereby the District has determined the need for school facilities to accommodate un-housed pupils that are attributable to projected enrollment growth from the development of new residential units over the next five (5) years.

4. The District's School Facilities Needs Analysis projects that over the next five (5) years new residential construction will generate a total of approximately 2,300 students in grades TK-6; 570 students in grades 7-8; 910 students in grades 9-12; and 70 Special Day Class (SDC) students that must be housed at a total allowable cost calculated pursuant to the requirements of Government Code section 65995.5, subdivision (c) for facilities, site acquisition and development of \$67,999,501 which when divided by the projected square footage of new residential units anticipated to be constructed over the next five (5) years' results in a maximum alternative residential fee of \$4.63 square foot of assessable residential construction (Level II Fee) and, as set forth below, if State funds for new school facility construction do not become available, and following the District's consultation with building and development industry representatives, a consideration of whether or not to impose an alternative fee under Government Code section 65995.7 (Level III Fee).

5. The purpose of the alternative Level II fee is to provide school facilities for unhoused students who will be generated as a result of the construction of new residential units in the District over the next five (5) years.

6. The alternative Level II fees are to be used exclusively for the school facilities identified in the District's School Facilities Needs Analysis consistent with Government Code section 65995.5, subdivision (f).

7. There is a reasonable relationship between the need for school facilities and the type

of development on which the fees are imposed because, as set forth in the District's School Facilities Needs Analysis, the construction of new residential units generates students that cannot be housed without additional facilities.

8. There is reasonable relationship between the use of the fees and the types of development projects on which the fees are imposed in that new residential units will generate students who will attend the District schools, these students cannot be housed by the District without the construction of additional facilities, and the fees will be solely expended to finance these new additional facilities.

9. There is a reasonable relationship between the amount of the fees and the cost of the facilities attributable to the construction of new residential units on which the fees are imposed in that the square footage of these types of units has a direct relationship to the number of students generated and, thus, to the facilities which the District must add to accommodate those students.

10. Pursuant to Government Code section 65995.7, the District is authorized to establish a fee in excess of the Level II fee in the event that the State Allocation Board is no longer approving apportionments for new construction in accordance with Education Code section 17072.20 due to lack of funds available for new construction, and the State Allocation Board notifies the Secretary of the Senate and Chief Clerk of the Assembly in writing of the determination that such funds are no longer available. The Board acknowledges that the State Allocation Board did notify the Secretary of the Senate and Chief Clerk of the Assembly in writing of the determination that such funds are no longer available on November 1, 2016, thus triggering the authority for school districts to impose Level III fees. The Board further acknowledges that the voters of the State of California subsequently approved Proposition 51 on November 8, 2016, a \$9 billion education facilities bond measure, but that to date no bonds have been issued or sold pursuant to that bond authority. The Board finds that the District's School Facilities Needs Analysis provides sufficient analysis and support to impose Level III fees in the amount of \$9.26 per square foot of assessable residential construction (Level III fees). Accordingly, the Board hereby determines that in the event that State school facility funding continues to be unavailable, the Board may take action to impose Level III fees at any time upon providing thirty (30) days' notice to the building industry, the Cities of Clovis and Fresno, and the County of Fresno. In the event that the State Allocation Board subsequently begins

approving apportionments for new construction once again, any Level III fees in excess of the Level II fee amount shall be reimbursed to those persons who have paid such fees.

BE IT ALSO RESOLVED that the Board conducted a noticed public hearing at its regular meeting of June 14, 2017, at which time information contained in the District's School Facilities Needs Analysis was presented, together with the District's responses to all written comments received regarding the School Facilities Needs Analysis. The Board hereby adopts the School Facilities Needs Analysis and incorporates its School Facilities Needs Analysis herein by reference.

BE IT ALSO RESOLVED that the Board hereby establishes an alternative Level II fee in the amount of \$4.63 per square foot of assessable residential construction and the alternative Level II fees will take effect on July 1, 2017.

BE IT ALSO RESOLVED that the District has established a separate account in which all Level II fees collected pursuant to this Resolution, along with any interest income earned therein, shall be deposited in order to avoid any commingling of the fees with other fees, revenues and funds of the District, except for temporary investments, and that the District is authorized to make expenditures or to incur obligations solely for the purposes for which the fees are collected, which the Governing Board hereby designates to be those purposes permitted by any applicable law.

BE IT ALSO RESOLVED that if the District has unexpended or uncommitted fees within five (5) years of collection, the District will make required findings or refund the fees as set forth in Education Code section 17624.

BE IT ALSO RESOLVED that the Level II fees established pursuant to this Resolution are not subject to the restriction contained in subdivision (a) of Government Code section 66007, and that no building permit shall be issued for any development absent certification of compliance by the development project with the fees imposed pursuant to this Resolution.

BE IT ALSO RESOLVED that the Superintendent give notice to all cities and counties with jurisdiction over the territory of the District of the Board's action by serving a copy of this Resolution, the supporting documentation and a map indicating the areas subject to the Level II fees on each agency and requesting that no building permits or, for manufactured homes and mobile homes, Certificates of Occupancy, be issued on or after the date of this Resolution without certification from the District that the Level II fees specified herein have paid.

WHEREAS, Government Code section 65995.6, subdivision (g), states that the California Environmental Quality Act, Public Resources Code section 21000 et seq. may not apply to the preparation, adoption or update of a School Facilities Needs Analysis or to the adoption of a Resolution pursuant to Government Code section 65995.6 regarding the School Facilities Needs Analysis; and

WHEREAS, in determining that the adoption of the District's School Facilities Needs Analysis and the establishment of developer fees under Government Code sections 65995.5 and 65995.7 are exempt from CEQA, a school district is entitled to file a Notice of Exemption with the County Clerk pursuant to California Code of Regulations, Title 14, section 15062.

THEREFORE, BE IT RESOLVED that the Board hereby finds that its action in adopting the District's School Facilities Needs Analysis under Government Code section 65995.6 and in establishing Level II alternative fees under Education Code section 17620 and Government Code sections 65995.5 and 65995.6 is statutorily exempt from the requirements of the California Environmental Quality Act pursuant to Education Code section 17621, subdivision (a), and Government Code section 65995.6, subdivision (g).

DISCUSSION:

The Provisional Internship Permit (PIP) is available when the employing agency knows that there will be a teacher vacancy, yet is unable to recruit a suitable candidate. The expectations of the employer and the employee are higher since these individuals will be the teacher of record and should be on a credential track. The focus of the document is meeting subject matter competency. Once a candidate completes subject matter competency, the candidate can be employed on a document such as a District Internship Credential. Candidate requirements include the following: (1) Bachelor's degree or higher; (2) passage of the California Basic Educational Skills Test (CBEST); and (3) specific course work or experience, explained in detail on the Provisional Internship Permit Information leaflet.

As required by the California Commission on Teacher Credentialing (CCTC), employing agencies offering employment to candidates on a Provisional Internship Permit are required to: (1) conduct a diligent search for a suitable credentialed teacher or qualified internship teacher; (2) provide the PIP holder with orientation, guidance, and assistance as specified in Title 5 Section 80026.5; (3) assist the PIP holder in developing a personalized plan (kept on file at the local level) through an agency-defined assessment leading to completion of subject matter competence; and (4) counsel the PIP holder to enroll in subject matter training.

DISCUSSION:

The current ASB software utilized at District school sites for ASB Accounting is AAPro®, which is a desktop client. The District is proposing to implement AAWeb®, which is the web-based version of the same software currently in use in our schools. This will allow District technology, financial, and school site personnel to operate with increased efficiency. Technology staff will have the ability to troubleshoot remotely; whereas currently they are required to be on site and must have access to a specific employee's computer. The upgrade will provide better internal controls as the finance staff and District leadership will have the ability to run District-wide financial reports streamlining the auditing and bank reconciliation process.

Harris School Solutions has provided the District with a 20-day implementation schedule that will include on-site training for site personnel. All aspects of the implementation plan are included in the one-time implementation fee.

FISCAL IMPACT/FUNDING SOURCE:

One-time implementation fee of \$27,000 and an annual subscription fee of \$35,200 for 44 site licenses would be included in the 2017-18 Adopted Budget.

California Education Code section 42603 authorizes school districts to make inter-fund loans between funds. It is in the best interest of the District to allow such loans in order to facilitate the investing of money and to avoid having to borrow money from outside financial institutions when one of the funds may have a cash shortage. This inter-fund loan process is utilized only as authorized by the California Education Code, which requires that the loan be repaid in the same year, or subsequent year, if borrowing takes place within 120 days of the fiscal year-end. The Education Code also does not allow more than 75% of the money held in any fund during the current fiscal year to be transferred. District Administration recommends the Board approve a resolution authorizing these inter-fund loans during the fiscal year of 2017-18 as needed.
